- Ben Champion reported that his office is developing a website on KSU's Sustainability Research Capacity. This will be an effort to catalog the university's resources. It will be a good cross referencing tool for the speakers' bureau.

### **Update on K-State Sustainability Task Force**

- This task force has been established and has met twice. The co-chairs are Bruce Snead and Barbara Anderson. The group is tasked with developing a road map for sustainability at the university and is exploring themes and classification systems for a committee framework to accomplish this goal.

### **Sustainability Education**

- The task force will be working on this issue. A future School of Sustainability Studies is envisioned as an interdisciplinary program modeled on the existing leadership studies program.

## **Sustainable Energy**

- Ruth Miller provided an update on efforts to construct a wind turbine on the Manhattan Campus. Current budget uncertainties will affect how fast this will happen. The turbine is on the ground. Ruth is working on a proposal to the Department of Energy for workforce development for wind energy.

## **Student Sustainability Activities and Plans**

- No student representative was at the meeting. Ken Barnard attended the student track at the Sustainability conference and reported that students had been very active and had plans for more activities. These include:
  - Participation in a national recycling competition
  - Game day recycling (there is a competition between KSU and KU)
  - SeeGreen Campaign
  - Bike sharing program
  - No Motor Monday
  - Promotion of reusable bag standard in Manhattan
  - Competitions to use the least amount of energy

## **New 4-H Sustainability Project**

- Several CESAS member organizations submitted a proposal to develop engineering and sustainability curricula for 4-H. This project will start soon. The funders are eager to begin the project and may provide additional funding so that the curriculum can be available for use sooner than originally planned.

## **Earth Day Activities**

- The Sustainability Task Force may apply for university funds for a speaker on sustainability issues. This may be coordinated with Earth Day.

## **20<sup>th</sup> Anniversary Celebration for the Center for Hazardous Substance Research**

- The CHSR will celebrate its 20<sup>th</sup> anniversary this spring. Ideas for marking the occasion are welcome. A speaker, event, or luncheon are ideas that have been suggested.

## **Other**

- Ruth Miller reported that today legislative hearings were being held in Topeka on net metering and renewable portfolio standard (RPS). There are several bills related to this issue on the docket this session. Also, the Wind Power Group will be meeting in February. The purpose of this group is to encourage the development of wind energy in Kansas by making the state appear wind friendly to industry.
