• The participants reviewed the tentative agenda and concurred on its content.

Higher Education Sustainability Act (HESA)

- Ben Champion and Larry Erickson briefly shared perspectives and noted that K-State would continue to monitor HESA developments and prepare for upcoming grant process and appropriations.
- Title 8 of the Higher Education Opportunity Act (HR 4137) includes Part U on sustainability in higher education. Grants to universities that are between \$250,000 and \$2,000,000 are authorized for the development of sustainability programs. There is a 20% matching requirement. Collaboration with business, government, and non-profit organizations is encouraged. The concept of integrating campus operations with multidisciplinary educational programs is included. The Act also calls for a summit meeting of higher education sustainability leaders and experts.

PEW Charitable Trust Initiatives

- CESAS partners are working on preliminary ideas (public education for sustainability) and crafting a white paper for proposal.
- Heartland Foundation (St. Joseph, MO, Judy Sabbert) recently joined the working group.
- Chet McLaughlin, Larry Erickson, and Wendy Griswold discussed particular thoughts and transformational learning via the Technical Outreach Services to Communities/Technical Assistance to Brownfields as a model for educating and empowering citizens-communities in decision-making and capacity building.
